Survivor Link AmeriCorps Programs

Survivor Link: Increasing Access to Evidence-based Care for Survivors of Domestic Violence, AmeriCorps State Grant Program.

Between 2015 and 2022, 470 AmeriCorps Survivor Link members have engaged in 238,725 hours of service across 70 community partner sites where they have implemented over 1,000 risk-informed safety plans with domestic violence survivors. Survivor Link has awarded ASU students \$1,286,666 in scholarship money and another \$725,309 in education awards.

Survivor Link: Enhancing the Public Health Response to Domestic Violence, Corporation for National and Community Service & The Centers for Disease Control and Prevention.

Beginning in 2022, Survivor Link expanded to 14 universities across 11 states; 99 members per year are building capacity in public health and public health complementary agencies for responding to intimate partner violence.

Curriculum Leadership & Development

Development and Oversight of Certificate Programs in Domestic Violence and Evidence-Based Practice

Undergraduate and graduate certificates include 6 units of internship and 9 units of classroom instruction. Students are required to take Domestic Violence and National AmeriCorps Service (3 units), and may choose from among the below electives for the remaining 6 units.

Undergraduate Certificate Courses

SWU 416: Domestic Violence & National AmeriCorps Service (required). Students learn about domestic violence and implementation of evidence-based practices with domestic violence survivors and perpetrators; complimentary to an internship.

SWU 417: Technology, Interpersonal Relationships & Abuse. This course examines the influence, impact, and role of information communication technologies within interpersonal relationships, including the ways that technology can further interpersonal abuse and mistreatment of marginalized groups.

SWU 418: Global Perspectives on Violence Against Women. This course examines experiences of and responses to violence against women globally, exploring the drivers and consequences of violence against women across geographic and practice contexts, and in relation to societal and structural forces (e.g., the global refugee crisis).

SWU 494: Domestic Violence Fatality Analyses. This course introduces the concept of domestic violence fatality review and applies it to the analysis of de-identified cases. Students will closely examine an array of deaths and the social, cultural, economic, and historical contexts within which they take place.

Graduate Certificate Courses

SWG 545: Domestic Violence & National AmeriCorps Service (required). Students learn about domestic violence and implementation of evidence-based practices with domestic violence survivors and perpetrators; complimentary to an internship.

SWG 546: Approaches to Teen Dating Violence Prevention. This course covers theoretical and practice frameworks for understanding and preventing dating violence in the adolescent developmental context, including a focus on risk factors and the impact of victimization.

SWG 647: The Domestic Violence Movement: An Intersectional Framework. This course examines the history of the domestic violence movement, with special attention to the role of marginalized populations and the unintended consequences of the movement. Using a macro social work perspective, the course prepares students for political and community advocacy to address domestic violence and sexual assault.

SWG 648: Intimate Partner Violence Risk Assessment. Using an evidence-based practice framework, this course imparts practical guidance on how to implement intimate partner violence risk assessment in social work practice. Students are encouraged to think critically about the use of risk assessment across practice settings.
