#### **COURSES TAUGHT**

#### Graduate

**Argumentation & Advocacy.** Course explores how communication functions in the execution and production of advocacy across contexts and perspectives.

**Democracy and Power in Organizations**. Course that examines how notions about and practices of democracy and power are constructed, negotiated, contested, and maintained communicatively within contemporary organizations.

Methods in Applied Communication Research. Course that emphasizes social scientific methods within the context of applied communication research.

# Undergraduate

**Organizational Communication**. Course that emphasizes pertinent communication skills, behaviors, and theories that exist within the organizational context. Topics include leadership, organizational culture, organizational systems, and superior-subordinate relationships.

**Employee Participation Processes in Organizations**. Course that emphasizes the history and practice of employee involvement programs both formal and informal and the communication processes that accompany such processes.

**Communication Training and Development**. Course that emphasizes methods of assessing communication within organizations and the construction of training and development processes to address organizational communication needs.

**Interpersonal Communication for Business and Professions**. Course that focuses on relational communication concerns within the organizational context with a particular emphasis on competent communication skills for entry-level/subordinate employees.

**Environmental Communication**. Course that explores how communication informs our understanding of nature, wilderness, and the environment and how our understandings of these ideas shape public policy, public debate, and public practice with regard to the environment.

**Applied Communication: Perspectives and Principles**. Course that emphasizes how communication theories and concepts can be applied to address societal problems.

**Intercultural Communication Workshop: International Exchange Experience**. Course that integrates intercultural communication theory and practice with a 4-week sojourn in the United Kingdom.

**Intercultural Communication**. Course that emphasizes intercultural, interethnic, and interracial communication. Topics include intercultural communication competence, intercultural adaptation, and cultural variability.

**Intercultural and International Communication**. Course that emphasizes intercultural and international communication and encompasses topics such as verbal and nonverbal cultural variations, development communication, and international media.

**Communication between Cultures**. Course that emphasizes the role of communication in the creation, maintenance, and enactment of culture.

**Empirical Research Methods in Communication**. Course that emphasizes the nature and structure of the communication discipline and the social scientific research methodologies that guide communication research.

**Communication Process**. Course that provides an overview of communication theory in a broad range of contexts including persuasion, interpersonal, organizational, mass media, intercultural, and health.

**Discussion**. Course that emphasizes small group communication and encompasses topics such as leadership, team development, and conflict.

**Interpersonal Communication**. Course that focuses on the process of dyadic communication and involves the examination and application of interpersonal communication theory.

**Fundamentals of Communication**. A hybrid introductory course that focuses on basic interpersonal, small group, and public speaking skills and concepts.

**Public Speaking**. Course that focuses on developing, preparing, and presenting public speeches and particularly emphasizes informative and persuasive speaking.

**Theory and Practice of Oral Discourse**. An introductory course that emphasizes rhetorical theory and oral presentation skills.

**Soccer: The Global Game**. Course explores soccer as a lens to understand issues of class, race, gender, identity, and nationality against a backdrop of sport commodification, globalization, and politicization.

International Cities - Barcelona: Sport, Place, Politics, & Identity (Study Abroad Course). This course explores how sport acts as a cultural agent to affect sense of place, nation building, and politics. Using Barcelona as the backdrop, the course considers how Catalan identity is exerted, contested, and advanced through modern sport entities including the Olympic Games and Football Club Barcelona.

**Soccer, Politics, & Identity**. The course explores the connections between politics and identity, paying particular attention to the historical and cultural factors that have positioned soccer as highly politicized force for enacting and reflecting one's identity.

**Fans, Ultras, and Hooligans: The Global Appeal of Soccer**. With passionate fans across the world, soccer fosters deep connections between fans, the clubs they support, and the places where they reside. This course explores identity, culture, politics, and activism associated with soccer fans from a global perspective.
