BIOGRAPHY

Olga I. Davis is Professor of Communication in the Hugh Downs School of Human Communication at Arizona State University. Her scholarly work examines the performative nature of communication, with a focus on the social determinants of health and health equity among underrepresented communities. She approaches research from a community-based participatory framework, and her work involves culturally grounded intervention research in evidence-based contexts. Her dedication to the mission of the university is seen in her community-embedded research that is translational and participatory in its vision, application and dissemination, and in her development of curriculum that aims to shape the research of next-generation health-disparities scholars in the field of health communication.

Dr. Davis is a disciplinary leader in critical cultural studies that explore identity and power and in health literacy. She employs use-inspired research to address the difficult questions about our urban and diasporic communities, both domestically and abroad. Her work centers on narrative discourse—how humans create identity and co-construct their world through the nature of telling stories. Most importantly, her methodology is grounded in community-based participatory approaches, which are used to explore the nature of health disparities and the role of health literacy, with the goal of achieving an equitable and healthy future for all communities.

Dr. Davis is the Principal Investigator of the African American Cardiovascular Disease (CVD) Health Literacy Demonstration Project, an NIH-NIMHD-funded project with ASU's Southwest Interdisciplinary Research Center (SIRC). Her work is innovative and collaborative; she partners with Black Barbershops to promote knowledge and community efforts toward eliminating the CVD mortality rate among African American men.
