CLINICAL PRACTICE, INTERESTS, AND ACCOMPLISHMENTS

C. SHORT REPORT OF CLINICAL ACTIVITIES

1. Clinical Practice (Service Coverage; Case Load and Complexity)

Massachusetts General Hospital:

- Practice limited to gastrointestinal pathology, including pancreas, liver, and biliary tree: diagnostic biopsies and resection specimens in a teaching hospital setting
- Full-time administration and senior pathology consultant of the MGH Gastrointestinal Pathology Service. This service has a total volume of about 6,000 cases/yr. Most cases are comprised of multiple specimens; therefore, the total diagnostic volume is approximately 11,000 specimens (3,000 resection specimens and 8,000 biopsies).
- 75% FTE surgical pathology practice with primary coverage of Gastrointestinal Pathology Diagnostic Service approximately 25 weeks/yr and diagnostic evaluation of about 2,500 cases

- Secondary coverage of Gastrointestinal Pathology Service with direct supervision of all diagnostic service performed by senior residents and fellows in training on the Gastrointestinal Pathology Service, approximately 8-12 weeks/yr (over and above FTE)
- Private consultation service in Gastrointestinal Pathology of about 100 cases/yr
- Full-time consultation for Gastrointestinal Pathology to the Autopsy Service
- High degree of complexity for all consult cases, the majority of diagnostic biopsies, and 50% of resections for malignancy

Shriners Burns Hospital

- Full-time administration of the Anatomic and Clinical Pathology Services and senior pathology consultant
- Sign out all surgical pathology cases excluding pigmented skin lesions (which are read by the MGH Dermatopathology Service): approximately 100 cases/yr
- Complexity: requirement for expertise in wound pathology and pathophysiology

McGill University Health Center

- Full-time administration of the Anatomic and Clinical Pathology Services and senior pathology consultant
- 20% FTE surgical pathology practice with primary coverage of Gastrointestinal Pathology Diagnostic Service approximately 40 weeks/yr and diagnostic evaluation of about 2,000 cases
- High degree of complexity for all consult cases, the majority of diagnostic biopsies, and 50% of resections for malignancy

2. Clinical Contributions: Care Delivery

- Reorganization of Gastrointestinal Pathology Diagnostic Service with establishment of practice guidelines for sign-out of gastrointestinal tumor specimens at the MGH to assure completeness and uniformity of reporting with use of:
 - Internationally accepted nomenclature for tumors
 - Internationally accepted pathologic staging of tumors
 - Commentary on all gross and histopathologic features of proven independent prognostic significant in specific gastrointestinal malignancies
- Provision of full-time consultation service in gastrointestinal pathology for medical and surgical subspecialties dealing with gastrointestinal disease

RESEARCH INTERESTS

A. REPORT OF RESEARCH

1. Major Research Interests

- Epithelial differentiation during wound healing and control of body site-specific differentiation
- Changes of expression of cytokine and cytokine receptor genes in wound healing
- Molecular mechanisms in cellular aging
- Molecular mechanisms of neoplastic transformation in the pancreas
- Histopathologic and molecular prognostic and predictive factors in colon cancer

2. Short Description of Research

a. Basic and Clinical Research in Epithelial Biology and Wound Healing

Cultured human keratinocytes, either used as permanent grafts or as biologically active wound dressings, have been studied in patients and animal models using histologic, ultrastructural, immunohistochemical, biochemical and molecular biological techniques.

Cultured autografts have served as model systems for the investigation of such biological processes as anchoring fibril, basal lamina, and hemidesmosome formation, epithelial hyperproliferation and differentiation during wound healing, epidermal site-specific phenotype expression, neuroendocrine differentiation in squamous epithelial, epithelial-stromal interactions, Langerhans' cell repopulation of epidermis, distribution and population density of HIV-infected Langerhans' cell in skin following infection, cellular aging induced by culture vs. chronological aging, and melanocyte behavior during wound healing.

The wound healing promotional effects of cultured allografts have been studied in *in vitro* models, animal models, and in treated patients. Endogenous epithelial cytokine production by the grafts has been studied on the levels of both gene expression and protein production and compared to topical applications of individual growth factors and growth factor combinations.

b. Clinical Research in Gastrointestinal Malignancy

Clinicopathologic correlative studies using histologic, immunohistochemical, and molecular biological techniques have focused primarily on colorectal cancer and pancreatic cancer and their respective precursor lesions to elucidate pathological features of either diagnostic or prognostic value in these diseases. Factors of interest have included proliferation markers, differentiation features, oncogene mutations, blood group antigen and mucin expression, and vascularity.
