Description: I investigated the impact of the real value of the dollar on investment in U.S. manufacturing using both industry and firm-level panel data. In contrast to previous research, I found robust evidence for negative effects of the real dollar on domestic investment via the channel of export competitiveness. I also found significant negative effects of dollar appreciation in firm subsamples defined by high degrees of export orientation, imported input use and import penetration, especially using industry real dollar indexes weighted by total trade and by imports.
