The role of the senior director of the Center is to develop and manage the resources of the center, working with the executive faculty director, to generate a conversation about the American Constitution and its perpetuation through programing (events and podcasting) and written contributions and exchanges (website, "Constitutional Conversations" Substack newsletter and podcast, and in public media) about the strengths and opportunities for perpetuation and reform of constitutional government in the United States and around the world, that serve the purpose of enhancing the stable rule of law and rebuilding trust in democratic institutions.

Associate Director for Public Programs, School of Civic and Economic Thought and Leadership

The School of Civic and Economic Thought and Leadership is an academic program dedicated to providing an education at the crossroads of liberal and civic education, and which also promotes robust public programing, designed to promote a healthy heterodox conversation across intellectual and political difference.

The Associate Director for Public Programs conceives, designs and invites participants, in consultation with the school leadership and faculty consultants, to develop the non-partisan and intellectually diverse content of the school's annual lecture series (the Civic Discourse Project), including invited speakers, an annual conference and student events (The SCETL Advantage series). The Associate Director for Public Programs also designed and managed the SCETL student internship, professional development program (2017-2021). I coordinate with the event staff team that executes the event logistics and work closely with the marketing and communications team to promote events.

- Annual Signature Events, Conceive and Design events, invite speakers for each of our annual signature events, which include: Constitution Day, Martin Luther King Day, Pre-Law lecture.

- The Future of Arizona Democracy, created critical partnership project of the Arizona Chamber Foundation Junior Fellows and the School of Civic and Economic Thought and Leadership (SCETL). It was born of a collaboration between the founding Junior Fellows leadership and SCETL public programing to create a public affairs series that focuses on the challenges confronting Arizona's democracy.
- <u>"Keeping It Civil"</u> podcast executive manager, conceives and manages, invites guests for podcast interviews.
- <u>Visiting Scholars</u>, Work with faculty to invite academic speakers of particular interest to our community of students, faculty, and partners, including those who come to visit us as "Visiting Scholars," short-term for 1-2 weeks, or long term for a semester, a program that I am also developing and running (see below);
