Research Interests

My research efforts focus on applied cognitive and social psychology, particularly in the domain of psychology and law. Within this area, I have concentrated on two topics: how juries make decisions and the reliability of eyewitness memory. My third area of focus is in applying decision making principles to everyday judgment tasks, as in medical decision making and distributive justice. I also enjoy teaching undergraduate courses on the history of psychology and introductory and experimental psychology. In addition, I have supervised 18 Undergraduate Honors theses and numerous independent research projects, and I administered the LSU psychology department's undergraduate honors program.

My overall course evaluations in undergraduate classes have averaged around 6.0 on a 7-point scale.
