#### PUBLISHED OR TECHNICAL REPORTS

• Since 2004, I have authored approximately 400 expert reports for asylum/refugee cases filed in the United States, Canada, Ethiopia, Uganda, the United Kingdom, Switzerland, and Israel by Eritrean/Ethiopian applicants and/or non-profit refugee rights organizations on applicants' behalf. Each report is approximately 12 pages long and based on original and current research. I have delivered oral testimony in approximately 15% of these cases. My reports have been cited in US federal circuit court decisions and in other major precedent-setting rulings elsewhere, including the

State of Israel.

• I served as lead author on the 2015 Concept Note and subsequent 2020 Draft Statement on Anthropology and Human Rights for the American Anthropological Association. This was the third statement on human rights issued by the AAA (following the 1947 and 1999 Statements). The 2020 Statement was adopted in July 2020.
