My recent work on caretaking strategies, residential context, and child health outcomes contributes to a broad focus on the influence of social experiences on health outcomes over the lifespan. I am currently developing a project exploring experiences of social support, psychosocial stress, adult health, and child

growth and development in Black populations in the greater Toronto area, Canada. This study is part of a broader research project investigating the long-term effects of migration and social upheaval on kin investment practices and health outcomes amongst contemporary island and diasporic populations.
