Thus far, the Student Research Society has developed marketing materials and planned research travel to national conferences. The society has also established connections to the USF Tampa Undergraduate Research Society.

## **6. USF Institutional Review Board Campus Approver for USFSM** 2018-2022

- Responsible for reviewing and approving all applications for human subjects research from the USFSM campus.
- Provided training in responsible conduct of human subjects research as well as the e-IRB Arc system for proposal submission.
