6. RESEARCH AND SCHOLARLY ACTIVITIES

My intent throughout my career has been to generate a portfolio of research that contributes to the management toolkits of front-line service providers in the urban and regional planning, human services, community development, civic engagement, and life quality arenas. One stream of research continues my historic focus on demonstrating the utility of benefits-based management, customer service and marketing principles in urban and regional planning. A second stream of research focuses on quantifying the role of public goods in economic and life quality development in local and regional communities. The third stream of research reflects my interest in quantifying and enhancing quality of life delivery systems in urban communities, and developing results-oriented solutions to social challenges. And, a fourth stream focuses on the intersection between lifelong learning, civic engagement, and life quality of older adults – with a particular focus on discerning predictors of abundant aging and human longevity. Through all these efforts, my thrust is to apply social science concepts toward the resolution of problems faced by planners and policy-makers at the federal, state and local community levels.
