- Analyzed historical and present issues such as education inequality, youth political participation, and gendered-based violence using scholarly journals and firsthand observations.

- Co-authored a literature-based analysis examining how civic engagement, including peer mentorship, community service, and restorative justice, supports mental health, identity reconstruction, and successful reentry among older formerly incarcerated adults in the United States.
- This paper examines evidence that highlights how civic engagement reduces age-specific reentry challenges such as social isolation, institutional disorientation, and declining health through fostering purpose, social capital, and emotional well-being.
- Refers to life-course, identity-transformation, and social-capital frameworks to call for policy and programmatic reforms that integrate civic engagement as a central, strength-based component of reentry for aging incarcerated populations.
