### TEACHING AND INSTRUCTIONAL ACTIVITY

### **Courses Taught at ASU**

### CRD 610 Sustainable Communities

This course serves as a foundational course for doctoral students. The course focused on systems thinking for promoting sustainable community. It considers issues at different scales, ranging from urban to rural, local to global, historical to contemporary. The course critically examines the role of public, private, and nonprofit institutions in promoting sustainable communities.

### CRD 552 Critical Issues in Community Development

The purpose of this course is to critically analyze the dominant concepts, theories, models and issues related to community development. This course identifies major social- ecological factors affecting communities and discussed the conceptual and theoretical approaches to understanding community development, and their implications in tourism, parks and recreation, and NGOs and nonprofit.

I developed this course in 2014 and I have been teaching since then.

#### REC 552 Critical Issues in Recreation and Tourism

The purpose of this course is to analyze critically the dominant concepts, theories, trends, models, and issues to explain leisure, recreation, and tourism. This course examines various global critical issues related to recreation and tourism, and their implications in management and research. This is a core course for the MS students in Recreation and Tourism Studies.

I developed this course in 2006 and taught until 2013. This course has now been revised and broadened to cover the critical issue of community development.

### TDM 480 Sustainable Tourism

This course critically analyzes the environmental, economic, and socio-cultural aspects of tourism development, and strategies to attain balance among these three dimensions to guarantee its long-term sustainability. This course helps students to understand the complexities involved in sustainable tourism.

I developed this course and taught both in-person and online.

### TDM 372 Tourism Planning

This course is designed to provide students with an overview of tourism planning at the local, regional and national levels. It provides a variety of practical planning theories, procedures and guidelines to meet the diverse needs of destination communities, tourism and hospitality organizations, public, non-governmental organizations, and the private sector. The course concentrates on developing student's competencies in the basic techniques of planning and developing sustainable tourism plan, products, attractions and services. In this course, I collaborate with cities and I involve my students' to prepare tourism assessment plan for the cities.

### TDM/PRM 401 Management of Tourism & Recreation Services

The purpose of this course is to provide students with a basic understanding of management concepts, skills and tools that are fundamental to effective management in parks and recreation, and tourism organizations, both private and public.

#### TDM 458 International Tourism

This course examines the significance of tourism as a vehicle for social and economic development, and its issues at the regional and global level. This course has the purpose of preparing students with the knowledge of importance of tourism, destinations, issues, and factors shaping the destinations in each region.

### TDM 325 Tourism Accommodation

This course introduces the lodging and food service industries and provides the tools and techniques for attracting travelers and meeting the expectations of hotel and resort guests. It examines the complex interrelationships of the lodging industry, career opportunities, and the international dimensions of the industry.

TDM 205 (formerly REC 305) Introduction to Travel & Tourism

This course examines the components of the tourism industry at the state, national, and global levels. This course has the purpose of preparing students with the most current knowledge of the interaction between tourists, providers, governing organizations and the host residents to help them become successful agents of positive change in the tourism industry.

REC 160 Leisure and Society

This course analyzes the human relationship to leisure. It provides an historical survey of philosophical, psychological, and socioeconomic bases for development of systems that provide leisure programs.
